EXPERIENCE TYPE BREAKDOWN

Medium sized business: These entities typically have annual revenues greater than R30m but less than R150m and generally have less than 1000 employees. They may also be family owned and controlled with a long established trading history.

Small business: These entities typically employ less than 30 employees and are almost always family or partner owned with localised operations. Their annual revenues are usually less than R30m and have simplified management and control structures.
